Extended G/L Accounts

Extended G/L Accounts is an enhanced replacement for the Sage G/L Accounts screen that provides a mechanism for maintaining a full or partial set of Sage 300 G/L Accounts across multiple companies <u>with</u> the same – or different – functional currencies.

Access is through the Copy Accounts button that has been added to the bottom of the Sage 300 G/L Accounts window.

Accounts and companies can be filtered and "cherry-picked", and the program includes sophisticated error-checking to protect against inconsistent multi-currency operations.

When finished a copy operation, you can view and print a full log of changed accounts.

See Important Notes regarding the operations to be performed in this document.

There are important distinctions between adding an account into multiple companies, changing an account description in multiple companies, and attempting to update all account properties across multiple companies (when a target account may already be in use).

Extended G/L Accounts lets you:

- Maintain a full or partial set of G/L accounts across multiple Sage 300 companies with the same or different functional currencies using the Copy Accounts functionality.
 - Specify a range of accounts from the current company, filter them by additional criteria, cherry-pick accounts from the results, and then copy the final set to other associated Sage 300 companies.
 - Substitute account segments.
 - o Select or de-select companies on an individual basis.
 - Update account descriptions only.
 - o Include account multicurrency information.
 - Display a full log of updated accounts.

Enterprise Productivity Tools appear if you have an Enterprise license from TaiRox Software.

Copy G/L Accounts to other Sage 300 companies

Extended G/L Accounts operates from within an existing "source" company for copying G/L accounts.

- Click the Copy Accounts button to pop up a window that allows you to select by range and filter accounts in the source company, filter and substitute account segments, then load and individually select or de-select accounts before copying.
- Click the Copy button on the pop-up screen to select from a list of "target" companies to which accounts can be copied and to select the operation to be performed (Insert Only, Update Only, Insert and Update).
- Click the OK button to start the copy operation. When copying is complete, you can review the log file by clicking the Log button.

IMPORTANT:

You must enter a User ID and Password to copy G/L account information. Make sure that the User ID has sufficient rights to complete the operation in the <u>target</u> companies.

If you are inserting new accounts into other companies, check that a current backup exists for all databases being affected.

• Open the Sage 300 company with the G/L accounts that you want to copy.

Copy Accounts operates from within an existing "source" company, and lets you copy account information to other "target" Sage 300 company databases.

• Open the Extended G/L Accounts form, and click the Copy Accounts button at the bottom of the screen.

Note: By default, the grid at the bottom of the form will display new accounts that were added in this session. This allows you to copy only the new account changes directly to other Sage company databases.

You can clear any accounts from the grid by selecting **File > Clear List of Accounts Changed This Session** from the File menu at the top of the form. The grid will also be updated when you click the Load button.

To copy or update any set of accounts, start at the top of the form to specify the range of G/L accounts that you want to copy or update. The program displays the last set of ranges and filters used for copying and updating accounts. Click the Load button to use the previous settings.

Specify range of G/L accounts for copying:

You can specify up to seven ranges of G/L Account fields to use for account selection – including the account number, structure code, account group code, or <u>any of the optional fields</u> that you use for G/L accounts.

 Click the Additional Criteria button to use any G/L account field to filter accounts for copying. Click OK to save.

Select accounts using ranges of segment codes:

You can specify ranges for all of the account segment codes.

For example, the following screen shows that only division 200 accounts will be included.

While other companies can be selected, <i>the operation will only be performed on those companies that have the target segment code</i> .						

For example, if one of your account segments shows the type of store – e.g. retail – you can copy the accounts with this segment to create a new set of Webstore accounts in another company DB.

- Select the Substitute Segment Code checkbox, choose the segment that you want to substitute values for, and then specify the source and target values.
- The new segment values must already be added to General Ledger using the TaiRox Extended G/L Segment Codes form or the Sage 300 Segment Codes form.

The operation will only be performed on those companies that have the target segment code. All exceptions will be logged.


For example, if you want to add accounts for new segment code "400" to a company, you must add the "400" segment code before you can copy accounts using segment substitution.

Load the list of G/L Accounts and choose which ones to copy:

• Click the Load button to display the list of G/L Accounts that match your selection criteria.

When you click the Load button, the program will display the G/L accounts in the account and segment ranges and with the additional criteria that you specified.

• You can adjust the ranges or additional criteria if necessary, and then click Load again.



 Click the Select All and Select None buttons at the bottom of the screen to include all or none of the accounts loaded in the grid for copying.



Click the Copy button to display the To Companies screen:

When you are happy with the set of accounts that you have selected, click the Copy button at the bottom of the screen.



Select whether to insert new codes or update existing ones in target companies:

Before proceeding, you must decide whether to add or update codes in the target companies.

For example, choose Update Only to update account descriptions for all accounts.

- Choose whether to insert, insert and update, or just update G/L accounts.
 - Insert Only will add codes if the code does not already exist in target companies. It will not change existing codes.
 - Update Only will only update codes in target companies that already exist but not add new ones.

If updating codes only, you can also choose to update the description only.

o Insert and Update will perform both of these operations.

Specify which data to update/insert:

Update Only Update Account Descriptions Only Include Account Multicurrency Information

- Choose which data you want to update account descriptions only or whether you want to include account multicurrency information.
 - o "Update Account Description Only" appears for Update Only.

This checkbox will change account descriptions only – it doesn't matter whether other account properties match.

The "Include Account Multicurrency Information" choice disappears if you choose "Update Account Descriptions Only".

 If you have multicurrency companies, you should select the option to "Include Account Multicurrency Information".

Before selecting "Include Multicurrency Information", you should clearly understand the possible consequences and check results first in a test environment. Seeking advice from a certified consultant familiar with multicurrency account setup is also recommended.

 Do not choose "Include Account Multicurrency Information" if the target company is a single currency company.

Copy Accounts will not copy **any** account information from a multicurrency company to a single currency company if you choose "Include Account Multicurrency Information".

 Except for the special case of changing the description only, an update operation will attempt to change the account in the target company to be just like the account in the source company.

In order to do so, it will delete various properties (such as Optional Fields) from the target account and then add the properties from the source account. It's possible for the update to fail if properties don't match or accounts are in use.

"Include Multicurrency Information" options:

This option lets you copy multicurrency accounts to a G/L that has a different functional currency.

For example, if you copied accounts to a target company with functional currency CAD, the default currency for each copied account would be set to CAD – as above.

If you do not select this option, the program will copy the default currency for the source account to the target company.

• Allow Posting in All Currencies.

This option selects the "Post in All Currencies" option in the target company for all copied accounts.

If you do not select this option, the program will copy the "Post In" settings from the source company – including lists of specified currencies from the source general ledger. (The program will add the default currency to the list if it is not there.)

Note that all multicurrency fields in the target account are ignored if the source account is not multicurrency.

- Click the Copy button to start the copy procedure.
- Enter your User ID and password in the Sage 300 Sign-On window and click OK.

Note: You MUST have sufficient permissions to update G/L accounts in the target companies for copying to proceed.

- The program will copy the G/L account information to the target companies.
- If no changes are required for a selected account, no update will be performed so the audit stamp will be preserved.
- If you cancel the operation during the copying process, you must check the log to see which procedures were completed and assess how you want to continue.

Click the Log button to confirm which G/L Accounts were processed:

The Log lists:

- The user, the type of operation performed, and the range of accounts.
- Each account that was processed and whether the accounts were updated or inserted.

Detailed example of Segment Substitution

Suppose we have a Segment Code "Division". Further suppose we have some accounts in Division 100 that we wish to copy to a new Division 300 in multiple companies.

Important Note: There are many different ways to arrange charts of accounts and segments across multiple companies. This section illustrates how Extended G/L Accounts can be used in one scenario.

Step 1: Create a new division

The first step is to create the new Division in all the appropriate companies using Sage G/L Segment Codes or the TaiRox Extended G/L Segment Codes screens.

Step 2: Specify a range of accounts for copying

The second step is to specify the range of accounts in the Copy Accounts function, in this case, account 5400-5410 with its Divisions and Regions.

Step 3: Specify a division with the accounts you want to copy

Since we are copying division 100 accounts, you need to specify the segment range on the Copy G/L Accounts screen:

Step 4: Select the Substitute Segment checkbox

Click on the Substitute Segment Code checkbox to display the fields for the substitution option. Specify that we want the accounts to be copied, substituting Division 100 with Division 300

Step 5: Click the Copy button

Click the Copy button to pop up a window where you can select multiple companies.

Note: when substituting segments, Extended G/L Accounts allows copying from a company to itself.

While other companies can be selected, *the operation will only be performed on those companies that have the target segment code*.
